

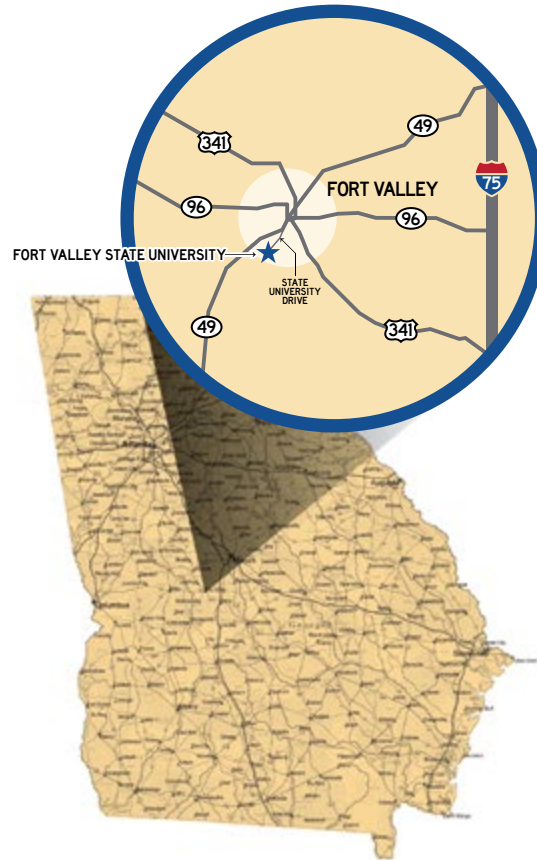
# What is the Mobile Information Technology Center?
